General Manager's Report/Events/Fundraising: Tim/Mimi

Year-end appeal: One of our major donors came through for us with a generous donation. Another donor gave a gift specifically meant to be put towards equipment; it will be put towards a new computer for the production studio. (Katie recommends the purchases be in this calendar year to take advantage of pricing.) Mimi noted it's always a good idea to check in with lapsed donors; this has proven fruitful in the last fund drive and year-end appeal. Overall it

builds community to be in contact with donors; whether it's by note or phone call. Tim has sent thank you notes to all of our business underwriters.

Music sale: There was a solid showing. Not as many people as last year but they were spending money. On the whole Mimi is happy with the results from the music sale.

One Small Step party at The Arnold House: This was an inspirational event that raised so much good will. People who participated came and spoke. Our representative from StoryCorps in the city came to the party and enjoyed visiting the station. The event was covered in local newspapers.

2025 Budget (Katie)

The proposed 2025 budget circulated to board members and there was a special meeting that BOT members could attend if they had any questions. A few stats: We have \$485,000 in the bank as of the end of November. This is a 16% increase from where we were this time last year. We have 9.6 months of runway. We're looking at a 7.6% growth in operating budget; We're investing in staff, technology upgrades and facility support.

We are increasing our fund drive goals in light of the fact that this has been a strong year for cultivating donors. We've also increased marketing by 5 % which will help. A goal is to reach a 1 million operating budget over the next few years; once we hit that we're in a better position to qualify for more grants.
