General Manager & Staff Update

Tim explained that the rescission package was approved by the House earlier this spring and is now with the Senate. We expect them to take it up after the Fourth of July recess. Everyone can help by signing up for ProtectMyPublicMedia.org While NYS Senators are expected to oppose rescission, if you know people in other states, please ask them to reach out to their Senators to express their support for public media. Congress must act by July 18th or the rescission request will fail and the funding is guaranteed for fy2026. It is always helpful to contact local representatives offices and express your support for WJFF and public media.

Nom and Gov Committee

Gerald Finn has decided to step down from the board and we have three great new candidates for the board.

Finance Updates

Katie explained that WJFF has access to a media insurance policy through our new membership in the Institute for Non-profit News.

Assuming the rescission package passes, the worst case scenario for WJFF is that we would not receive the remaining \$130K in grants from the CPB that were included in this year's revenue budget. At this point we have exceeded some revenue projections and the staff has been very mindful of expenses, with that being said, our estimated deficit post-recision would be roughly \$113K. Our reserves will cover this and we are working to identify additional ways to increase revenues and reduce expenses.

In addition, the FEMA Next Gen Warning System grant funds which were awarded in 2024 continue to be at risk, having been repeatedly revoked or frozen. The funds are currently frozen, and will expire on September 30th if the associated work is not completed and reimbursements are not approved within that timeframe.

As of May 31, the station has \$322K in cash and \$152K in investments. These reserves are healthy and have given us a run way of 21 months without federal support.

Membership is up, potentially as a result of the threat to our funding. We are hopeful that our supporters and community members will show up for us if the rescission package passes, but know that we cannot anticipate membership filling the entire gap that the loss of federal government funding would leave. We will continue to pursue

additional foundation grants, building on our success and momentum from previous grant awards.

Katie reminded the BOT that the mortgage remains our largest debt liability, and that we will want to keep a close eye on rates as well as look for loan refinancing options for non-profits.

The cost of the Media Insurance is more than we budgeted. There was discussion as to whether it is truly needed. What are peer stations doing? As the station moves into more journalistic news reporting rather than softer reporting we need to be mindful of the risks involved.

Katie explained the need for a hold harmless and indemnification clause for non-employees (i.e. volunteers). It acknowledges that the volunteer is responsible for the content they create and is broadcast by WJFF.
